CALL TO ORDER:

BUSINESS ITEMS:

1. OFFICER'S REPORTS AND APPROVAL OF MINUTES

- T. Huffhines signed checks, produced minutes
- o T. Lewelling signed checks, and visited with volunteers
- D. Tillman transferred funds to cover bills
- T. Huffhines motions to approve minutes for Sept. meeting minutes, Lewelling seconds, all in favor.

2. ADMINSTRATIVE REPORT/SCFD: Chief Teague

- 71 calls in September EMS (46) Fire (5) Service & Good Intent calls (11) False Alarm (2)
 Special Incident (4) Hazardous conditions (3)
- O Volunteers repainted much of the interior space, repaired sheetrock and added trim
- Brush truck 44 is eligible for Ford Warranty repair but ESD6 must remove some body parts before the work (adding braces) can be done by Ford
 - Ford could pay for some of the cost
 - ESD6 could incur costs but an estimate will be provided
- O TX Forest Service sent ESD6 a grant of 120K for small brush truck- good for one year.
 - Currently ESD6 has 4 brush trucks 1996 Dodge, 2007 Dodge, 2008 Dodge and 2018 Ford
 - The plan is to take the 120K and add a maximum 80K out of savings to purchase a new Brush truck approximate time to receive truck 6 months
 - Plan to sell the 1996 Dodge
- Suicide and assault numbers were up above average in September
- A gentleman that Cresson and ESD6 shared as a volunteer was asked to leave due to improper behavior.
- T. Huffhines motions to authorize Chief Teague to spend up to \$225K towards a brush truck,
 T. Lewelling seconds, all in favor.

3. FIRE DEPARTMENT REPORT - CRESSON:

- Total of 69 calls for September (last July count was 72) -. 761 calls through end of September (3 structure fires, Two trucks dispatched to Hood County for fires)
- Breakdown of calls
 - PCESD6 = 17, City of Cresson 3, Johnson County 5, Hood County 15, Tarrant 29 -32 were EMS.
- O Response time 7:23 avg. 1:40 turn-out and 5:43 travel time
- Truck insured through Hood County was underinsured
- Brush 430, 1999 Chevrolet has a leaky tank replacement cost is ~9K, Engine was recently replaced as well.
- Next Sunday, City of Cresson will hold the Chisholm Trail 100 event and the Fire Department will stage an Engine at the event

- Total roster of 73 (9 seniors, 3 special members and 9 on military leave) Responder total comes to 51 (5 juniors, 29 members and 17 on probation)
