3. FIRE DEPARTMENT REPORT - CRESSON:

- o Total of 65 calls in October vs. 70 in October of 2022, 767 YTD 831 same period in 2022
- Breakdown of calls -PCESD6 = 20, City of Cresson 0, Johnson County 3, Hood County 17, Tarrant – 25 (22 were EMS related)
- Response time 8:06 travel time avg. Computer generated times of 1:25 for turnout and 5:41 for travel
- Significant calls
 - Large grass fire south edge of Ft. Worth
 - Sunday morning residential structure fire in hood county Mom reportedly left a 3 yr. old home alone which was saved by neighbors
- Getting a new 4000 gallon tanker truck yahoo!
 - total cost estimated at \$653,834
 - Delivery estimated 180 days from this date
- Hood County commissioners court last Tuesday voted to fund a new 4 bay building on the existing property of station 1 – estimated cost \$538,000
